  - for election as Members of Council (to serve 2019-2022):
    - ➤ Professor Roderick Beaton: Roderick Beaton grew up in Edinburgh where he first studied Latin and ancient Greek before going on to Peterhouse, Cambridge, graduating with a BA in English Literature and a PhD in Modern Greek. He came to King's College London in 1981 as Lecturer in Modern Greek Language and Literature, and in 1988 was appointed to the Koraes Chair. For ten years he headed the Department of Byzantine and Modern Greek Studies, and from 2012 to 2016 was Director of the Centre for Hellenic Studies.
    - ➤ Dr Joseph Skinner: Joseph Skinner read Ancient History at St. Andrews (MA Hons; M.Litt.) before going on to Leicester for an MA in Archaeology (Professional Archaeological Practice). After taking a year out to work as the school's archaeological illustrator he then relocated to Liverpool for a PhD under the supervision of Professor Tom Harrison. He spent a year at the British School at Athens preparing his thesis for publication returning to Liverpool where he taught Ancient History from 2010-2013. In 2013 he was appointed a Lecturer in Ancient Greek History at Newcastle University.

- ➤ Dr Andrea Capra: Andrea Capra graduated with an MA in Classics from the University of Pisa and a PhD from the University of Milan. Prior to joining Durham in 2017 he spent a few months as a visiting scholar at the Cambridge Faculty of Classics, then worked as a 'Liceo' teacher in Greek, Latin and Italian literature (students aged 13-19) before being appointed to the University of Milan. In recent years he has been a Residential fellow at the Harvard Center for Hellenic Studies (2011-2012) and the Princeton Center for Hellenic Studies (2017).
- ➤ Dr Rosa Andujar: Rosa Andujar was educated at Wellesley (BA 2003) and at King's College, Cambridge (BA Hons 2005), before completing her postgraduate studies in Classics at Princeton (MA 2008, PhD 2011). Prior to joining King's in 2016, she was the first A. G. Leventis Research Fellow in Ancient Greek Literature in the Department of Greek & Latin at University College London (2012-2016). In 2019 she is Visiting Professor in Brazil at the Federal University of Paraná.
- Ms Tatiana Bur: Tatiana Bur is a PhD student at Trinity College Cambridge. Her PhD (Ancient religion; ancient technology) examines the human techniques and technical knowledge employed to manufacture religious aura in the Graeco-Roman world. Tatiana joined Cambridge in 2016 from the University of Sydney and her research interests span anthropological and comparative approaches to religion; intellectual history (especially of the Hellenistic period); new approaches to ancient science (particularly through technical manuals); and ancient entertainment.;
- that Council be authorised to appoint auditors for the accounting reference period 1 January to 31 December 2019.
