

Committee meeting held at
74 Lower St on Thursday Oct. 30 1879
at 5 P.M.

Mr Newton being voted into the chair opened the proceedings
by calling upon the Secretary to read over the names of those
who had at the last meeting been put up as candidates for the
Society. This being done their election was duly confirmed by

The chairman then proceeded to read through the rules
as amended at the last meeting, after which they were discussed
in detail and various new amendments passed & introduced.
In the objects of the Society, at the suggestion of Mr Freeman, from
whom the Secretary read a letter, the words "in the Levant"
were omitted. In Rule 18 Mr Prof Sayce proposed that
the President & Vice-Presidents should hold office for
'three' instead of 'one' year. Being seconded by Mr Macmillan
it was put to the vote but lost by a large majority.
In Rule 28 it was decided that candidates must have the
votes not of 'two thirds' but of 'the majority' of the
members present in the Committee. In Rule 32. Prof.
Sayce suggested proposed that the no. of British Honorary Members
should not exceed 'five' the present number being 'twenty'.
This was lost, but a second amendment proposed by Dr
Smith to read 'ten' instead of 'twenty' was carried
unanimously.

The Chairman next brought forward the question of ~~&~~ the Presidency of the Society, explaining that it would be impossible for himself to hold the office, as it had been generally hoped that it would do. He expressed his willingness to take the Chair at the ensuing General Meeting but after that the Presidency must be regarded as vacant. He therefore called ~~the~~ upon all Committee members of the Committee to turn their attention to this matter, it being necessary that they should have a President to propose to the General meeting. Several names were suggested but no certain conclusion arrived at.

S Smith then stated, with reference to the periodical meetings which the Society hoped to hold later on, that the Royal Literary Fund, of whose Council he was a member, had a good room at 7 Adelphi Terrace, which he thought could be hired for such meetings at the rate of about £20 a year. The suggestion was received with favour and the Hon Sec was requested to look at the room in question, & report to the Committee at their next meeting. The meeting then broke up.
